

SNP ARRAY TESTING – INFORMED CONSENT

You have the opportunity to participate in FORENSIC INVESTIGATIVE GENETIC GENEALOGY (FIGG), searching to assist organizations and genealogists working on behalf of Law Enforcement agencies in solving cases involving violent crime or missing persons.

Intended purpose

DNA from your donated sample will be used to generate a unique genetic SNP profile. Your DNA profile will be compared to other profiles in publicly accessible databases with the intention of finding, or matching with, genetic relatives to identify:

- 1) Victims or perpetrators of violent crime
- 2) Missing Persons

Matching Parameters

Your profile will be included in the match lists for unidentified human remains cases that result in a match.

If you (donor) choose to participate in FIGG searching, your information will be included in the match list of a FIGG Law Enforcement user account for criminal cases <u>only</u> if both of the following criteria are met:

- i. You have opted in to Law Enforcement matching (purpose of this notice).
- ii. You and the genetic profile results uploaded to a Law Enforcement account result in a match.

Information Shared

By opting in to FIGG searching, a FIGG Law Enforcement user can view certain elements of your personal Information, including de-identified SNP profiles, your DNA relationship, and public profile information.
